The Planners Corner

In the 'Planners Corner' series, we will explore the City Planner's (Planning and Codes Department) role to help the community reach its goals and vision, through various strategies and tools



CODES ENFORCEMENT



The Code Enforcement Staff addresses property maintenance and clean-up violations outlined in the City of White House Municipal Code. This includes excessive and unattended growth of weeds/grass and illegal signs. Furthermore, staff works toward the repair or removal of dilapidated buildings, structures, and vehicles. The Code Enforcement staff works within requirements as set forth in the Municipal Code, Zoning Ordinance, and Tennessee Annotated Code to improve the quality of life and property within the City of White House.

Code Enforcement Staff has operated on a complaint basis because of the limitation of staff. With the recent addition of Jenna Nelms, the two

Building Inspectors, Tony Covington and Sean Hagan, are able to focus on the quality and safety of structures. While Jenna is able to not only assist with the duties of the Planning office and helping Mrs. Rita Hobbs, she's also able ensure Property Maintenance rules are being followed.

If you notice a property that might fall into one of the categories as shown in the images shown, we invite you to call, email or interactively report an issue. You can report an issue by visiting the city's website. On the homepage you will see a large button that says "Report an Issue". You can also download the mobile app to keep our Code Enforcement Staff aware of any potential



violations. One thing we are improving is our communication on the status of a complaint. We have gotten feedback that once a resident registers the complaint, no mitigation occurs. For more clarity, I encourage you to read the City of White House Municipal Code to understand the process by state law that staff is required to follow. We have to cite the offender to remedy the violation. If nothing happens within that time frame, then they are cited to court, where the judge makes a ruling. An example would be a high grass complaint. In the past, Code Enforcement cites the code violator. If nothing was done, the next step was to send out a contracted lawn service professional to remedy the high grass. This was a tax payer budgeted expense that the city was reimbursed for. These steps are being adjusted to give the violator time to address. If not addressed, the

property owner is then cited to court and fined by the judge according to his ruling. Our staff will then send out someone to bring the high grass into compliance. The city will then be reimbursed for the lawn service by the property owner. With the aforementioned process, the citizen that filed the complaint, might not be

looped in to the process. It is our goal to better communicate the status of the complaint.

Our columbarium has 48 niches (hollow spaces) for the safe keeping of your loved one. Each niche can accommodate two family members.

In an effort to help make this the safest of holiday seasons, the White House Police Department is encouraging citizens to pay particular attention to their surroundings during the holidays.

Police offer the following holiday safety tips while shopping:

Stay alert to your surroundings and the people around you.

Shop with a friend whenever possible. There is safety in numbers.

Avoid carrying large amounts of cash.

Pay for purchases with a check or card.

If possible, carry only your driver's license, necessary credit cards or personal checks.

If you must carry a purse, do not wrap straps around your arms or shoulders. You could risk injury from a would-be purse-snatcher.

Do not carry wallets in a back pocket.

When possible, slip bags/purchases in nondescript bag(s).

Watch your purchases while eating in mall food courts; bags can be easily snatched.

Have your car keys ready in hand before leaving the store.

Ask security for an escort to your car if you are uncomfortable walking alone.

Glance in the back seat and under your vehicle before getting in.

Don't leave packages in your vehicle in plain view. Lock them in your trunk and out of sight.

Report all suspicious/criminal activity to the White House Police Department at 672-4903. Always dial 9-1-1 for all life threatening emergencies.

It's the Season for Shop with a Cop/Firefighter



Every year the White House Police Department and the White House Fire Department assist local children through the "Shop with a Cop and Firefighter" program. This program sponsors children from disadvantaged families to provide Christmas gifts for the children. The children are partnered with a Police Officer or a Firefighter and allowed to shop at Wal-Mart for Christmas presents for themselves and family members. For many of the children this event will be the only Christmas gifts they receive.

Of course, if a business or individual is interested in being part of sponsoring future fundraisers or providing donations for the yearly program to assist in continuing this program, donations can be made at the Farmers Bank located on Hwy 76 and Hwy 31W. The donation will need to be given to the White House Rotary Club with specifications that the donation is for the Shop with a Cop and Firefighter program. FIRE DEPARTMENT

As the holiday season approaches the White House Fire Department would like to remind you of the following safety tips.



TURKEY FRYER FIRE SAFETY

Frying food puts you at the greatest risk of cooking fires. Before you fry a turkey, review these tips to keep you and your loved ones safe.

Turkey fryers can tip over easily, spilling hot cooking oil over a large area. Make sure your turkey fryer is on a sturdy, level surface and do not move it once it is in use.

Make sure it is at least 10 feet from your home and not under roof eaves.

An overfilled cooking pot will cause cooking oil to spill when the turkey is put in. Test the amount of oil you need by filling your fryer with water. Place the turkey in the pot making sure the water doesn't get too close to the top. Measure the water and use that as a guide for filling the pot with oil.

A partially frozen turkey will cause cooking oil to splatter when you put it in the cooking pot. Make sure your turkey is fully thawed without frost on it before you fry it.

Without thermostat controls, deep fryers can overheat oil to the point of starting a fire. If your turkey fryer does not have a thermostat, use a kitchen thermometer that attaches to the side of the pot. This will help you monitor the temperature of the oil.

The sides of the cooking pot, lid and pot handles can get dangerously hot. Always use protective oven mitts. Keep children and pets at least 3 feet from the turkey fryer.



CHRISTMAS TREE SAFETY

As you deck the halls this holiday season, be fire smart. A small fire that spreads to a Christmas tree can grow large very quickly.

Choose a tree with fresh, green needles that do not fall off when touched.

Before placing the tree in the stand, cut 1–2" from the base of the trunk.

Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights.

Make sure the tree is not blocking an exit.

Add water to the tree stand. Be sure to add water daily.

Use lights that have the label of an independent testing laboratory. Some lights are only for indoor or outdoor use.

Replace any string of lights with worn or broken cords or loose bulb connections. Connect no more than three strands of mini string sets and a maximum of 50 bulbs for screw-in bulbs. Read manufacturer's instructions for number of LED strands to connect.

Never use lit candles to decorate the tree.

Always turn off Christmas tree lights before leaving home or going to bed.

Get rid of the tree after Christmas or when it is dry. Dried-out trees are a fire danger and should not be left in the home or garage, or placed outside against the home.

One of every three home Christmas tree fires are caused by electrical problems.

A heat source too close to the tree causes one in every five of the fires.



WINTER HOLIDAY SAFETY

Always keep a burning candle within sight. Extinguish all candles when leaving a room or before going to sleep.

Never burn a candle on or near anything that can catch fire. Keep burning candles away from furniture, drapes, bedding, carpets, books, paper, flammable decorations, etc.

Keep candles out of the reach of children and pets. Do not place lighted candles where they can be knocked over by children, pets or anyone else.

Keep anything that can burn at least 3 feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.

Have a 3-foot "kid-free zone" around open fires and space heaters.

Never use your oven to heat your home.

Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.

Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.

Remember to turn portable heaters off when leaving the room or going to bed.

Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.

Test smoke alarms monthly.



Stormwater Drainage



FAQ's

Common questions associated with the City of White House MS4 Stormwater

Question: There is new construction behind my lot and I'm having drainage problems due to the construction. Is there anything the City can do to make the developer drain his development away from me?

Answer: There is a misconception that new development is not allowed to drain onto existing development. If the area drained onto the adjacent property prior to development, it may continue to do so after development. **New development may not worsen existing drainage patterns.** If problems are being created during construction, please contact the Public Services Department at 615-672-3654 and we will investigate to determine whether the development is being properly constructed and that runoff is being properly managed.

Question: The new construction behind my house is causing a lot of dirt and sediment to enter my yard. Can the City require the builder to place erosion protection on his lot?

Answer: Please contact the Public Services Department at 615-672-3654. It is helpful if you know the name of the adjacent development. The developer of a subdivision or a commercial site is required to maintain stormwater pollution prevention controls on the property until adequate vegetation is established.

Question: My neighbor has been draining his swimming pool onto my lot. Who can I contact to stop this?

Answer: If the pool is draining onto private property, then it is a civil matter between property owners.

Question: My neighbor has done some work on his lot and now I'm getting more runoff. What can I do?

Answer: These situations are civil matters between the property owners. It is not a violation of state law or city code for one lot to drain onto another, and you should try to perform work on your lot to help your yard drain more efficiently. **It is against state law to divert or concentrate runoff, or block runoff from draining onto your property. We advise that you meet with your neighbor and discuss the problem to work toward a mutually agreeable solution.** If this is not possible, consider grading swales on your property to convey the runoff around your home. Swales are depressions similar to wide shallow ditches that will collect runoff and take it to a more desirable area, typically the street. If swales are graded, care should be taken to ensure that grass is established so that they do not immediately fill up with silt. Occasionally, area drains may be considered. However, we do not generally recommend them for surface flow situations. Area drains typically do not have the capacity to handle the volume of runoff that is threatening to flood a home, and must be frequently cleaned of leaves and debris to function properly.

Question: A hole has developed in my yard over a City pipe system. What can the City do?

Answer: Please contact the Public Services Department at 615-672-3654. If the system is public, we can investigate the cause of the problem and repair the system if necessary. If the system is private, then the owner of the system is responsible for maintenance.

Question: Am I allowed to construct a fence crossing a drainage easement?

Answer: Fences are allowed in drainage easements in some situations with a signed waiver. A fence permit must be obtained from the Public Services Stormwater Division for any fence construction. Proposed fences within drainage easements will be evaluated by the Public Services Department for utility functionality. Fences are never allowed across concrete channels, within natural creeks, or within the floodway.

SANITATION SERVICES



The City of White House Sanitation Division will renew its current contract with GFL through June 30th 2023. During this time, the city will bid and review costs regarding trash collection services. It should be no surprise with current inflation causing cost increases in areas such as labor, materials, and fuel that the cost of services will subsequently see an increase. How much, we don't know yet. We do know, however, that the city will undergo a 5% increase in January 2023 and the city will absorb this increase to avoid additional costs to our residents. The Sanitation Division will continue to negotiate in the best interests of the city and retain quality service during this transition period.

Under Title-17 Chapter 17-113 the city offers two **free** disposal drop-offs per year at the Public Services Offices, located at 725 Industrial Drive, White House, TN 37188. This supplementary service can be used for small trash accumulation from households within the city limits. This free service is offered during normal working hours: **Monday through Thursday 7:15am to 5:15pm** (40 Hours) in order to keep fees waived to our city residents. This free convenience service is not to be confused as a county/city dump. The city does not offer "Dump" services per se, nor are we licensed as such, but instead a convenience service offered to White House residents for excess items of garbage.

Robertson County Solid Waste and The Sumner County Resource Authority are alternatives for larger items, such as mattresses, construction debris and electronics. Robertson County is open **Monday – Friday 7:00am – 3:15pm and Saturday 8:00am – 12:45pm. Sumner County is open Monday – Friday 6:00am – 5:00pm and Saturday 7:00am – 4:00pm.**
